## 1. Introduction

This Cookie Policy explains how CinePath Ltd ("we," "our," "us") uses cookies and similar technologies when you access or use CinePath online services including Cine3D, Cine3D Pro, ConveyPro, and related platforms.

Cookies are small text files stored on your device that allow websites to function efficiently and provide insights into usage. We use them strictly to support secure login sessions and analyse platform performance.

By creating an account or using CinePath services, you consent to our use of cookies as outlined in this policy.

## 2. Types of Cookies We Use

### a. Essential Cookies

These cookies are necessary for the operation of our platforms. They enable features such as:

- Authentication ("remember me" login sessions).
- Secure access to user accounts.
- Load balancing and server security.

Without these cookies, core site functions will not work.

Expiry: Session cookies expire when you log out. "Remember me" cookies expire automatically after 30 days unless you log out sooner.

### b. Analytics Cookies

We use Google Analytics to monitor site traffic, server load, and user engagement with our applications.

Collected data is anonymous and used only to improve system performance, capacity planning, and usability.

Retention: Analytics data may persist for up to 12 months under Google's default settings.

### c. Security and Monitoring Cookies

CinePath internally monitors system use to detect automated botting, spam requests, and unauthorised access attempts. These security logs are stored securely in the United Kingdom.

## 3. Third-Party Cookies

We do not use third-party advertising, tracking, or social media cookies. Embedded media (e.g. YouTube or Google Maps) are not currently used on CinePath websites.

## 4. Consent

Cookies are not set until you create an account or log into a CinePath service. By registering for and using CinePath platforms, you acknowledge and agree to this Cookie Policy.

If you do not agree, you may continue to browse public pages without logging in, where no cookies are stored.

## 5. Managing Cookies

Most browsers allow you to control or delete cookies through settings or privacy options. Disabling essential cookies will prevent you from accessing your CinePath account and related services.
