All waste streams are segregated and disposed of through licensed, environmentally responsible collection services.

4. Sustainable Materials and Production

CinePath prioritises the use of sustainable and recyclable materials whenever technically feasible.

Material selection for 3D printing, prototyping, and production considers recyclability, energy footprint, and local sourcing to reduce transport emissions.
