1. Introduction

These Terms of Service (“Terms”) govern the use of all websites, software, and online services operated by CinePath Ltd (“CinePath,” “we,” “our,” “us”), including Cine3D, Cine3D Pro, CineDRAW, ConveyorPro, and any future CinePath platforms (collectively, “Services”).

By accessing or using any CinePath Service, you agree to be bound by these Terms and all applicable laws. If you do not agree, you may not use the Services.

2. Eligibility and Accounts

a. Browsing Access

Visitors may view general site content without registering. Pricing and order functionality are restricted to approved users.

b. Account Registration

To access full features (including purchasing, quoting, and file submission), users must create an account. Account approval is subject to CinePath verification and may be withdrawn at any time if these Terms are violated.

c. Account Security

You are responsible for maintaining the confidentiality of your login credentials. You agree to notify CinePath immediately if you suspect unauthorised use of your account.

3. Use of Services

Users agree to use CinePath Services only for lawful purposes and in accordance with these Terms. You must not:

- Upload or distribute unlawful, obscene, offensive, or confidential materials.
- Submit 2D or 3D models that depict or facilitate weapons, explosives, or restricted products.
- Attempt to reverse engineer, copy, or misuse any CinePath software or systems.
- Engage in automated scraping, spamming, or denial-of-service attacks.

CinePath reserves the right to suspend or terminate access for any misuse.

4. Quotes, Pricing, and Orders

a. Quotes

All quotes generated through CinePath systems are non-binding until an official quotation document has been signed in writing by both CinePath Ltd and the customer.

b. Pricing

Prices and product details are accessible only to approved account holders. Prices are subject to change without notice prior to acceptance.

c. Orders

Orders are accepted once an invoice has been issued and payment received.

5. Intellectual Property

All software, site design, text, graphics, and media remain the property of CinePath Ltd. Users retain ownership of their uploaded 2D and 3D models and drawings but grant CinePath a limited licence to use, store, and process these files solely for the purpose of providing the Services.

Paid services such as CineDRAW licences and physical production work are invoiced manually.

Cine3D Pro is currently provided free of charge.

CinePath reserves the right, at any time and without prior notice, to introduce licensing, approval, or paid-access requirements for any existing or future CinePath product or service.

CinePath also retains full rights to suspend, modify, or withdraw any licence or account access for breach of these Terms or misuse of its systems.

7. Limitation of Liability

CinePath Ltd will not be liable for:

- Any indirect, incidental, or consequential loss arising from use of our Services.
- Any data loss, delay, or error due to network, user, or third-party systems.

Total liability under any claim shall not exceed the total amount paid by the customer for the affected order or licence.

CinePath Services are provided "as is" and "as available." While we strive for accuracy, we do not guarantee uninterrupted access or error-free performance.
